Guidelines for Submitting New Seated, Online, and/or Blended Graduate Course Proposals

Please submit one original course proposal and a cover sheet, along with an electronic copy, to the Dean of The Graduate School, HAB 804. Be sure that the cover sheet includes appropriate signatures.

In using the outline below please enter, for every item, both the number of the item and a brief subhead (e.g., 6. Indicate how frequently....) so that readers will understand the entries. Number each page of the proposal.

NOTE: Please use person first (e.g., student with a learning disability as opposed to learning disabled student) and gender inclusive language.

Part I: Summary Information for College Records

Course proposals for seated, online, and/or blended courses require submission of Part I and II.

1. Title of Course: Please limit to 30 units, including spaces. If it is absolutely necessary to use a longer title, please select a clear, understandable abbreviation. Remember that it is the abbreviation, and not the long title, that will appear in the Schedule of Classes and on students' transcripts.
2. Full Course Number (3 letters/3 digits): Departments may select the course number from among those not currently in the Course Master File. Please do not select a number previously assigned to a course for at least two years after it was officially dropped.
3. Catalog Description (approximately 35 words): Please do not include wording such as "This course is..."

 - a. Type of Instruction (Lecture, lab, tutorial, etc.)

 - d. Contact Hours & Number of Class Sessions per week (Lecture classes require one hour for each credit; laboratories require two hours for each credit.)
 - e. Facilities (equipment, space, etc.) if applicable

 - g. Class size limit (i.e., maximum enrollment) with a justification for this limit
 - h. Grading method (i.e., regular letter grade or pass/fail)

(NOTE: For online and/or blended course proposals, the committee expects clarity regarding how you will assess non-traditional work, such as discussion postings.)**

1. Is this course entirely online or is it a blended course? If it is a blended course, please state the percentage of the course that will be offered online.
2. Pedagogical Approach: How are the planned modes of instruction appropriate to an online approach? For example, do they take advantage of the interactive and multimedia capabilities of the Internet by creating exercises, discussion assignments, and/or online research projects for students? Extensive reliance on lectures given in seated courses is questionable. If use of lecture material is preferred, describe the digital format to be used.
3. Assignments and Activities: How will you demonstrate, through course assignments and activities, an understanding that the expectations of students taking an online course generally differ from those of students taking a conventional course?
4. Mode of Evaluation and/or Assessment: How will you account for the requirements of evaluating and/or assessing this online course at a distance?
5. Monitoring online discussions: How will you demonstrate an understanding that monitoring and assessing students' participation in e-discussions differs from evaluating student participation in face-to-face discussions?
6. Development of Online Learning Community: Which strategies will you use to develop an online learning community?
