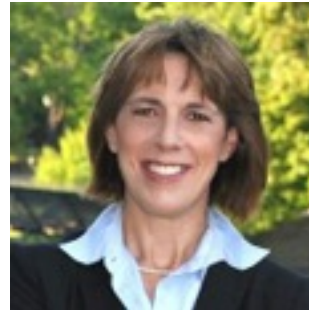

Interns will be expected to perform a wide variety of duties, including assisting the Regional Director and Deputy Regional Director in daily office operations, policy research, and event planning. Additionally, interns will be responsible for providing constituent services to individuals who contact the office seeking assistance. Interns will be able to work with all levels of Senate staff, other federal, state, local agencies. Interns will frequently work on team and individual projects, as well as develop ideas for local, state, and federal policy.

Students who apply for this internship should demonstrate a high level of maturity and professional responsibility. Experience working in a government or political office is preferred. The New York State Political Science Association invites proposals for panels or individual papers for our 2015 Annual Conference.

Our 69th Annual Conference will be hosted by the State University of New York at Plattsburgh.

The conference provides an excellent venue for academics, researchers, students and professionals in private and public organizations to discuss issues and share their work relating to political science and associated disciplines. We welcome proposals from history, philosophy, psychology, gender studies, economics, law, organizational studies, and sociology as well as interdisciplinary proposals. Conference highlights include NYSPSA awards for the best conference student and faculty/practitioner papers.

NYSPSA prohibits multiple paper submissions. Only one paper submission per person will be accepted. However, a paper presenter may also serve as a chair or discussant on another panel or roundtable. Questions should be directed to the conference Program Chair or appropriate Section Chair (see below).

If you are proposing a paper, please submit an abstract of no more than 500 words. The abstract must describe the presentation's purpose, methods, data sources, existing literature, and potential contributions to the field.

If you are proposing a full panel, please note that individual papers must be accepted (that is, we will require information on the individual papers before a panel proposal can be accepted). Additionally, all proposed panels must have a minimum of three papers and a maximum of five.

## Conflict in Ukraine: How Did We Get Here? How Can We Get Out?

**Victoria Vernon, Ph.D. Empire State College, SUNY**

The armed conflict in Ukraine today is deeply rooted in the history, economy, politics and culture of a profoundly divided nation. This talk will address the origins of the current conflict, the roles played in Ukraine by Russia and the West and the possible paths forward from here.

Victoria Vernon grew up and went to school in Ukraine, receiving a B.A. degree at Kharkov State University in 1995. She will draw on her personal and academic experience to shed light on the current conflict. An assistant professor of economics at SUNY Empire State College, where she currently teaches a course on history of the Soviet Union, Dr. Vernon holds a Ph.D in economics from the University of Texas at Austin. She was a visiting lecturer for 3 years at Princeton University where she taught the economics of Russia and Eurasia.

**Winter Human Rights Delegation to Rwanda**

Global Youth Connect is still accepting applications for our 2015 Winter Human Rights Delegation to Rwanda.

NOTE: Rwanda is Ebola free, and working hard to keep it that way. Rwanda's Ministry of Health, led by Dr. Agnes Binagwaho (with whom GYC's groups have frequently met at length), is exceedingly well organized and working day and night to ensure the country remains Ebola free. GYC's Executive Director can personally confirm that people coming into the country are being treated as suspect, with no-touch thermometers taking temperatures regardless of which country passengers are coming from. Passengers must fill-out a questionnaire as well. Several suspected cases were reported and pro-actively isolated over the past two months, but all proved to be something else (malaria, etc). The last message from the US Embassy in Rwanda concerning Ebola is here: [http://rwanda.usembassy.gov/sm\\_083114.html](http://rwanda.usembassy.gov/sm_083114.html). The US Embassy (with which GYC registers any and all participants regardless of nationality), updates travelers to Rwanda whenever necessary. Rwanda is over 2500 miles from the West African countries which have been most heavily impacted by Ebola.
