



## 2021 SUMMER AID REQUEST FORM

- ✓ File your 2021-22 FAFSA.
- ✓ Register for summer classes. You must be registered for 6 credits or more to receive loans.
- ✓ After you have registered, complete this form and submit to the Office of Financial Aid by July 12, 2021.  
**YOU MUST BE REGISTERED PRIOR TO SUBMITTING THIS FORM TO THE OFFICE OF STUDENT FINANCIAL SERVICES**
- ✓ Request a deferral from the Office of Student Accounts if you intend to wait for your aid disbursements to pay your balance. Otherwise, you'll need to pay by the due date on your invoice.
- ✓ Summer loans are expected to disburse after July 1, 2021. If you drop below 6 credits you will not be eligible for loan disbursements.
- ✓ Students are able to split their Summer Session bills into TWO equal payments. More information is available online or by contacting the Office of Student Accounts.

**NOTE:** Most students who receive direct loan funds for summer will see a **reduction** in their direct loan amounts for future semesters of the 2021-22 academic year, since the yearly allocation will be divided in thirds.

#### Pell Grant Recipients will automatically be awarded Pell for Summer 2021 if eligible.

Students may be eligible to receive up to 150 percent of their Scheduled Award for an award year. This provision is called Year-Round Pell. It is called “Year-Round” because, typically, it allows students to receive Pell funds in summer in addition to the amount received for fall and spring semesters.
