

Notes from Professor Ozler - On Sabbatical in Turkey



This semester I am on sabbatical in Turkey doing research, along with Professor Brian Obach from the Sociology department. We are studying the environmental movement and the civil society organizations working for environmental protection. Our research is informed by the literature on global civil society. Scholars have found that countries tend to effectively implement policies when they are party to international agreements and have active civil society organizations to ensure fulfillment of those obligations. Turkey is currently involved in a process through which it hopes to join the European Union. In order to do so, it must meet a set of standards required of EU members. We

wanted to determine if and how Turkish civil society organizations utilize EU environmental requirements to leverage domestic policy change.

We're using a number of different methodologies to answer our research question, but our main focus while here has been to interview the actors involved in this process including NGO leaders, activists and government officials. We have been interviewing NGOs leaders from all different types of organizations. Some of these organizations are more established nationally like the World Wildlife Fund Turkey and the Turkish Foundation for Combating Soil Erosion, for Reforestation and the Protection of Natural Habitats. Others are professional associations like the Chamber of Engineers. The Turkish Bar Association has many lawyers in their Environmental Commission who file lawsuits pro bono for those who do not have resources. We have also interviewed activist leaders from villages that are threatened by mine or power plant development where they grow food. We also talked to some organizations that are trying to dissociate themselves from the state all together in order to create alternative models of sustainable living, like eco-villages using permaculture systems. There is so much to analyze in the interviews, but we already see that there are complications associated with our hypothesis and the expectations implied by the literature. Although the EU process and other environmental obligations that the Turkish government has undertaken should foster progress in the policy arena, many environmental leaders see difficulty in using these international pressures to their advantage at this point in time.

That's because the current government has put forth a tremendous development agenda. They have essentially suspended their efforts to enter the European Union while seeking to rapidly build the Turkish economy. Many of their development goals are environmentally damaging including building two nuclear power plants, 60 coal power plants and hundreds of hydroelectric power plants in ecologically sensitive areas. There are hundreds of kilometers of new road being laid, and bridges and new airports being built. These efforts support the most polluting industries and there is very little emphasis placed on the development of renewable energy.

I look forward to sharing with you our results next year once we write our paper. In the meantime, Istanbul has had very nice weather allowing us to walk to almost all of our meetings, except for when we have to cross the Bosphorous channel. We have been learning a lot and enjoying our work. But I miss New Paltz, my colleagues in the department and of course, most of all, my students. The only thing I have not missed is the horrible winter I hear you are having.
