# PRESENTER SPOTLIGHT Chuck Mishaan

Being a computer technologist, I was recruited for the position of Bard LLI's AV Chair back in the pre-Covid days when classes still met on campus. At that same time, January 2015, while I was attending a performance of Tchaikovsky's opera Iolanta, a protester marched onto the stage of the Metropolitan Opera (perhaps the most famous stage in the world) and unfurled a banner protesting Vladimir Putin and his 2014 annexation of Ukrainian Crimea. He pointed at Anna Netrebko, the soprano, and Sergei Gergiev, the conductor, both good friends of Putin, who were taking their bows. The audience and Met security were astonished at this breach, and the protestor was walked off the stage and arrested. This experience deepened my exploration of opera as a political force.

I have been presenting this series of lectures on Opera as Politics, quite popular even with those who don't especially like opera, at area LLIs, including Bard, SUNY New Paltz, Vassar, Marist and Lifespring Saugerties, since that 2015 experience. Of particular interest to me was how opera, and the arts in general, incorporated political messaging, in ways both obvious and subtle, and how the arts reflected the political and cultural issues of their times.

When the Covid pandemic struck in 2020, the parallel experience of the Roaring 1920s, including the Great Influenza epidemic, intrigued me. Other parallels were the disruptive advances in technology-radio, automobile, cinema, phonograph, airplanes then; internet, AI, social media now. Debates raged about voting and women's suffrage, eugenics and birth control, Darwinism. We saw the rise of authoritarianism in Germany and Italy after the Great War, Jim Crow and racial division, the Red Scare, labor unrest, the Great Depression and Nazism. So many of the political and cultural issues then are with us today.

Since my particular interest is in intellectual history and how the arts reflect the political and cultural issues of their time, the 1920s became a fertile field of interest for me. Political, cultural and technological tensions found an explosion of expression and invention in the arts of the 1920s- abstract painting, stream of consciousness writing, atonal music, Bauhaus architecture.

Both opera and the 1920s are platforms for exploring important and current politics, and that is the excitement and insight I hope to convey in my SUNY LLI lectures. Thank you for being such an appreciative audience.

### **DUES CHANGE**



"The more things change, the more they stay the same". This quote is so true as it pertains to the membership dues for LLI. At the on-start the policy of LLI was that dues would be annual with no ½ year dues. Then after ten years, the council realized that new members were penalized if they joined in midyear (spring session), and changed the requirements for **first time new members**, allowing them to pay \$75 for a one-time ½ year registration for the Spring session. Last winter LLI added a short Winter session to the schedule. Members who had not paid for the full year but wanted to take the winter classes had to pay for a half year membership of \$75.

Once again, the Council has taken into consideration the changes in the needs of the membership and readjusted the dues schedule as of registration this fall 2022:

- Annual membership which includes Fall, Winter and Spring sessions \$120.00
- Part year membership which includes Fall and Winter sessions **or** Winter and Spring session\$75.00

LLI's annual fee allows members to take a total of six classes each fall and spring session; a total of 12 classes. This equals \$10 a class if you take the maximum number. The Part year membership costs only \$12.50 for six classes.

Membership fee entitles you to enroll in classes from a diverse selection of courses. You are also invited to many other LLI events, including trips and informative seminars

### **Member-at-Large**

The Bylaw provisions of Lifetime Learning Institute (which are posted on the LLI at SUNY website) identifies the members of the Council. It includes "three Members-at-Large (MAL)". Most people would ask what is a member-at-large and what do they do? In short, the role of the MAL is to be a liaison between the members and the council. Among the duties and responsibilities listed for MAL is to "attend council meetings and brings members ideas and/or concerns to Council's attention". So, the MAL is your representative on the council. You have questions about how classes are scheduled or if you wonder how speakers are invited to brunches, the MAL is the person to contact. You want to volunteer to be a presenter or a classroom assistant, the MAL would help guide you to the person to talk to. You have an idea of how things can be run more efficiently, speak to the MAL.

At the current time the council is looking for someone who would like to join as a member-at-Large. If this position interests you, please either call 845-257-2892 and leave a message or speak to someone on the Council regarding your interest.

### MEMBERSHIP BENEFITS

Once the campus reopens for visitors: The classrooms we use on Wednesdays and the technical support the presenters receive during classes are all provided free from SUNY. The SUNY administration is happy to have LLI on campus and offers the following discounts and opportunities to our students beyond our reduced-price parking tags:

Members are allowed to join the new Wellness Center on campus for a reduced fee for one semester or for the year. This gives one access to the circuit, the weight room and the dance classes. The old Elting Gym also has a swimming pool, racquetball courts and ping pong tables available.

The Department of Fine and Performing Arts gladly accepts the LLI membership card as a form of student identification. The card allows one to pay the reduced student rate for art (Dorsky Museum), theater (McKenna and Parker) and special events (Lecture Center). You can use the library but by becoming a Friend of the Library for a minimum donation of \$30, you are able to take books out of the library as well.

The various campus dining options are always available to everyone. The remodeled Wooster Hall (which is just across the concourse from Humanities and Lecture Center classes) now hosts a lovely restaurant.

### **AUDITING SUNY-NEW PALTZ CLASSES**

Once the campus reopens for visitors: Persons over 60 years of age, who would like to audit a course must obtain an audit form from the Office of Records and Registration. The completed form must have the approval and signatures of the chair of the department offering the course and the course instructor. The audit form must be returned to the department offering the course by the end of the "course add period."

The audit privilege permits the auditor to attend a course, providing there is room in the course and the necessary approvals have been granted, and to do assignments, but it does not permit the auditor to take examinations in the course or to have his/her work evaluated in any other way. The auditor receives no grade for the course, nor is any record of course attendance kept in the Office of Records and Registration.

Audit privileges are not ordinarily available in studio, online, laboratory or performance courses, or courses where class participation of students is of major importance, nor are they available in credit-free courses offered by the institution or in any foreign study program or course.
