VP Search

Due to the unexpected resignation of this year's VP, there is no sitting president of the LLI Council the VP was the head of the search committee for a president for next year, but when he resigned the search was temporarily halted. Letters were sent out to the membership asking for help in searching for a president, but the responses were very sparce and those who were suggested, declined. Faced with the situation, the council has determined a temporary solution. While the search for a current Vice President/President for next year continues, members of the council will rotate the chair of the president. Currently the secretary, Janet Philips will be Council Chair for three months, succeeded by the treasurer, Marilou Abramshe for three months. It is our firm belief that by that time a VP will be found who will take the reins of LLI in the Spring of 2023.

General Meeting

The LLI General Meeting was held on Tuesday, June 13 at Woodland Pond. There were about 28 members present. The minutes of the 2021/22 meeting were approved and a financial report was given detailing the income and expenses of the year (see accompanying article). Amendments to the By-laws were proposed and accepted by the membership. Theo Pappas, the outgoing president gave a report on the activities of the previous year. Janet Philips, the LLI Secretary presented Theo with a certificate and gift in recognition of her leadership for the past year. After thanking Janet and the members, Theo opened the floor to questions. A major concern was the lack of a president for the upcoming year and members of the council assured that the council will run things under a temporary Council Chair until a president is elected. Also discussed was the need to attract younger members over 55 to the organization. Several suggestions were made that will be discussed in council at a later date.

LLI AT SUNY NP MEMBERSHIP/BENEFITS

Full year membership fee of \$120 entitles you to enroll in classes out of a diverse selection of courses in both the Fall and Spring semesters. A single semester fee is \$75. Both fees entitle you to register for Zoom classes in the winter session when held. You are also invited to many other LLI events, including trips and informative seminars.

The classrooms we use on Wednesdays and the technical support the presenters receive during classes are all provided free from SUNY. The SUNY administration is happy to have LLI on campus and offers the following discounts and opportunities to our students beyond our reduced-price parking tags:

Members are allowed to join the new Wellness Center on campus for a reduced fee for one semester or for the year. This gives one access to the circuit, the weight room and the dance classes. The old Elting Gym also has a swimming pool, racquetball courts and ping pong tables available.

The Department of Fine and Performing Arts gladly accepts the LLI membership card as a form of student identification. The card allows one to pay the reduced student rate for art (Dorsky Museum), theater (McKenna and Parker) and special events (Lecture Center). You can use the library but by becoming a Friend of the Library for a minimum donation of \$30, you are able to take books out of the library as well.

The various campus dining options are always available to everyone. The remodeled Wooster Hall (which is just across the concourse from Humanities and Lecture Center classes) now hosts a lovely restaurant.

AUDITING SUNY-NEW PALTZ CLASSES

Persons over 60 years of age, who would like to audit a course must obtain an audit form from the Office of Records and Registration. The completed form must have the approval and signatures of the chair of the department offering the course and the course instructor. The audit form must be returned to the department offering the course by the end of the "course add period."

The audit privilege permits the auditor to attend a course, providing there is room in the course and the necessary approvals have been granted, and to do assignments, but it does not permit the auditor to take examinations in the course or to have his/her work evaluated in any other way. The auditor receives no grade for the course, nor is any record of course attendance kept in the Office of Records and Registration.

Audit privileges are not ordinarily available in studio, online, laboratory or performance courses, or courses where class participation of students is of major importance, nor are they available in credit-free courses offered by the institution or in any foreign study program or course.
