Sustainability in Higher Education's (AASHE) STARS program or the Real Food
Criteria may be automatically added to this list.

- o Certified Organic under an IFOAM-endorsed standard
- o Marine Stewardship Council Blue Ecolabel
- Monterey Bay Aquarium Seafood Watch "Green Best Choices" (if unavailable, "Yellow
   Good Alternatives" and "Recommended Eco-Certifications" will count)
- o Certified Bird Friendly (coffee)
- o Demeter Certified Biodynamic
- o Food Alliance Certified
- o Protected Harvest Certified
- o Rainforest Alliance Certified
- Salmon Safe Certified
- o Sea Choice "Green Best Choice" (if unavailable, "Yellow Some Concerns" will count)

#### OR

- Local.
  - o Local food is procured within 250 driving miles or within New York State.
  - All production, processing, and distribution must occur within 250 driving miles or within New York State.
  - Local food products from publicly traded corporations will be considered on a case by case basis.
  - o For multi-ingredient/multi-source products, 50% or more of the ingredients (by weight, excluding water) must meet the above definition for it to be considered local.
  - o Food sourced closer to New Paltz is preferred to food sourced from farther away, provided that the more local food is affordable.

#### OR

• Other Sustainable Food Attributes. The Sustainable Food Committee will consider other foods that do not fit in the definition outline above as sustainable on a case by case basis.

This is a *working definition* of sustainable food. In the future, the Sustainable Food Committee can revisit this definition and propose to adopt changes to improve it.
